# **FOOTLITES DANCE STUDIO POLICIES**

### PLEASE READ ALL POLICIES AS SOME HAVE CHANGED, INITIAL AT THE BOTTOM OF THE PAGE

**REGISTRATION / ENROLLMENT:** An annual non-refundable \$35.00 registration fee for each active FootLites Student account is due upon enrollment. Included in this fee is a FootLites T-shirt (given out in May). Once a student is enrolled, tuition will continue to be charged each month through June.

<u>TUITION:</u> Our program is based on a 9 month season (Including picture week and dress rehearsals) running September through June. Monthly Tuition is the same each month, regardless of attendance, school closures, and holiday vacations. Class Tuition is due the <u>25th</u> of each month. If payment is not received within 10 days, a <u>LATE FEE of \$15.00</u> will be assessed for each outstanding balance per account, per month. Please pay on time. **A \$40.00** fee will be assessed for all NSF Fund payments regardless of how the payment was made. Payments may be made by check, cash, Visa, MasterCard, or online via your parent portal. Autopay may be set up at any time. **Auto pay will be taken out on the 25th of the month.**\*\*\*10% Discount: We offer a 10% discount if you pay your tuition in full by Sept. 15<sup>th</sup>. Payment may be made by **cash or check, no credit cards.** The discount is only applied to those students registering for the full 9 month season (Sept-June). This does *not* apply to Dance Explosion Tuition and will exclude the sibling discount.

<u>AUTOPAY/CARD ON FILE</u>: All accounts will be **required** to have a card on file. If your account is 30 days past due, your card on file will be charged for all amounts past due. If the card is declined, you will be required to enter a payment plan to bring your account current. The card on file will be charged a minimum of \$50.00 every 2 weeks until your balance is paid. Please contact Mary Jill or Mandi if you need to discuss an alternative payment plan policy.

**REFUNDS:** In the event FootLites is REFUNDING a payment made; any payments that were made by credit card, the refund will be less the credit card fees, currently credit Card fees are at 4.5%.

\*\*If your card gets declined for any tuition fee or purchase, you will be charged the CC fee.

ATTENDANCE/PARENT PICK UP: Attending class on a regular basis ensures progress for all students and excessive absences puts a dancer behind his or her class. Please avoid missing class as much as possible once recital choreography is started. Please contact the studio if your child will be absent due to illness or other commitments. Dancers should arrive no earlier than 20 minutes before classes and be picked up promptly once they are done for the day. Dancers 11 and under are required to have parental supervision until they are in class. A \$1.00 per minute wait fee will be charged to your account if your student is left at the studio longer than 20 minutes or is left unsupervised.

**CLASS PLACEMENT:** Class placement is done on an individual level and is determined by the instructors. We take into consideration the dancer's ability and certain age restrictions.

<u>DROPPING/CHANGING OF CLASSES:</u> You may not drop or change classes in the current month you are in. An add/drop class form must be filled out and turned into the office by the **20th** of the current month to be effective for the following month. **Your class will not be dropped or added just by informing your instructor**. If this is not followed and your form is not signed and turned in by the **20th** of the month, you will be charged the next month's tuition for that class(es). Please contact the office for the drop class form.

<u>COSTUMES:</u> Each student participating in the Spring Recital will be responsible for purchasing a costume for each routine they perform in. This costume fee does not include tights, props and appropriate dance shoes for performances. A \$50.00 costume deposit, per routine, and \$75 hip hop costume deposit is due no later than Nov 1st. The remainder of your costume balance is due in January during costume week when all costumes are chosen. If the balance is paid after Jan 9th, additional shipping charges will be added to your account along with a \$15 Late Fee per costume. Costumes will not be ordered without full payment. All costume fees are non-refundable. **Costumes will not be handed out to any student with an outstanding account even if your costumes have been paid for.** 

<u>RECITAL:</u> All students are encouraged, but not required, to participate in our annual Spring Recital held at the Capitol Theatre. All accounts must have a zero balance in order to participate in our Spring Recital. All balances must be paid by June 1st or a \$15.00 Late Fee will incur. Tickets will go on sale in May through the Capitol Theatre.

<u>CLASS OBSERVATION:</u> Open curtains for parent viewing is at the discretion of the teacher, however, we will have select Parent Watch Days throughout our season. Please be sure to monitor any siblings that are here during instruction time, no children under the age of 12 may be left without parental supervision.
